7 Report of Honorary Treasurer

BO'D This year has been a challenging year for everyone, the QMU included. The usual aspects of fundraising for the union have been closed throughout the year. We've utilised JRS has been our main source of income this year. We've also utilised the Arts Schemes from Creative Scotland and claimed the maximum possible.

With the union being closed for most of 8 months, and a low bar period through Freshers' Week, funding has been massively reduced. The costs associated with income streams have been reduced to combat this with a tight close control of expenses.

The issue we've had going back for a few years is that we've had no reserves and since we have been trying to build up a reserve to convince auditors that we are not an ongoing concern (a 12 month period without concern of closure)—we use the university's support to combat this, but would seek to not have to rely on university through sufficient funding. This is still down the line, but we currently have around 4-5 months of cash flow to sustain the union if no funding came in.

It is worth mentioning within Northern Services we are the only Union to have made a surplus in the last 12 months.

LFar Numbers are getting better.

BO'D That's true, we're beginning to look forward to the future and be more positive.

RFri The reports are from 2019, is that correct?

BO'D That will all be changed when we resubmit.

SZar Did Ruaraidh send a report? I can still get one out to sort this.

GSim Creative Scotland funding—is there any stipulations on how that gets used?

MDav Creative Scotland funding cannot be used for capital expenditure- they are coming in to speak to us about how we can use it, and how we have used it. So far we have just used it to keep the venue running during cancelled events.

In theory it can be used for Freshers' Week, but it may not, we still need to look how the venue funding is looking come Freshers' Week and potential gig cancellations or delays into the future.
